## **Membership Classifications**

### **Family Membership**

- \$100 for the first two members (can be two Seniors or a Junior and a Senior) plus \$10 for each additional Junior.

### **Friends of Horses Membership**

- Reduced rate membership intended for individuals who are non-riders/non-drivers/non-competitors, who are not active in daily equine activities, or who are volunteers.
- Includes liability insurance benefits only. No other benefits apply.

### **Temporary Membership (Temporary Competition Fee)**

Must be purchased from:

- MHC prior to participating in the event/competition

OR

- The show organizer prior to participating in the event/competition
  - Show organizers must submit completed forms and appropriate payment to MHC within 5 days after the event/competition
- Provides liability insurance coverage to the individual for the event/competition for which the membership was purchased only. No other benefits apply.
